2949 **WHEREAS** by *Notice of Application* issued in this matter on 28<sup>th</sup> June 2012, it was published that Irma B. Smith as Attorney-in-Fact for Eleanor Charles Nibbs, Enelle Smith, Mildred Charles George, Leona Charles

Simmonds and Lorna Charles as Personal Representative of the Estate of Jean Austin Charles (Deceased), had filed an application to partition land as follows:

- Lot 3 on survey plan CA-2535B-008-T and Lot 1 on survey plan CA-2635B-118-T to be registered to Eleanor Charles Nibbs
- Lot 1 & 1A on survey plan CA-2535B-008-T and Lot 2 on survey plan CA-2635B-118-T to be registered to Enelle Smith
- Lot 4 on survey plan CA-2535B-008-T and Lot 4 on survey plan CA-2635B-118-T to be registered to Mildred Charles George
- Lot 2 on survey plan CA-2535B-008-T and Lot 3 on survey plan CA-2635B-118-T to be registered to Leona Charles Simmonds and
- Parcel 10 on survey plan CA-2535B-008-T to be registered to Lorna Charles as trustee for the estate of Jean Austin Charles.
- The remnant of Parcel 3 on survey plan CA-2535B-008-T and Parcel 10 on survey plan CA-2635B-118-T, will remain registered in the names of Phillip Heraldo Charles, Heirs of Elaine Frazer and Leroy Glanville Charles.

**AND WHEREAS** the facts show:

- 1) The acreage of Parcels 3 and 10 of Block 2535B, and Parcel 10 of Block 2635B (the "Property") is 2.77, 0.976 and 4.005 acres, respectively, for a total of 7.751 acres altogether;
- 2) The Property is family land which was originally intended to be treated as one family estate for the purpose of dividing and sharing the estate;

**AND WHEREAS** on enquiry by the Chief Registrar of Lands, the private surveyor concerned indicated that the estate road for Parcel 10 Block 2635B, which is sketched on survey plan CA-2635B-118-T in the 2.224 acres that will remain post partition and which is required to service not only the remnant lands, but Lots 3 and 4 of the current partition, measures 0.444 acre, thereby leaving approximately 1.780 acres of useable land in the said Parcel 10 to be shared by the remaining three proprietors who are not a party to this Application;

**AND WHEREAS**, as confirmed by the said the private surveyor, of the 0.444 acre set aside for the estate road in Parcel 10 Block 2635B the portion needed for Lots 3 and 4 is 0.162 leaving a further 0.282 acre portion in road together with the 1.780 acres of useable land to be shared by the said remaining three proprietors as they see fit;

**NOW THEREFORE IT IS HEREBY DETERMINED and ORDERED** that:

(1) the Property be exceptionally partitioned as one combined family estate as applied for and published in the *Notice of Application* issued on 28<sup>th</sup> June 2012 (details shown in the table attached to this Order), which represents the closest possible match to the eight proprietors' share entitlement, the reasonable utilization/distribution of the Property which accords with prior family agreement, the history surrounding the Estate, the varying sizes of the three parcels, and the geographic distance between them;

(2) the estate road for Parcel 3 Block 2535B needed to serve Lots 2, 3 and 4 be partitioned in the current Application as shown on survey plan CA-2535B-008-T;

(3) The portion of the 20-foot estate road required for access to Lot 3 in Parcel 10 Block 2635B be delineated and partitioned as part of the current Application as sketched on survey plan CA-2535B-118-T, and the sketch of the remaining portion of the estate should remain intact with the approximate acreage shown;

(4) The amended survey plan required to give effect to (3) above should be prepared and submitted to the Land Registry within 30 days of the date hereof for final processing.

(5) The names Eleanor Charles Nibbs, Enelle Smith, Mildred Charles George, Leona Charles

Simmonds and Lorna Charles as Personal Representative for the Estate of Jean Austin Charles (Deceased) be removed from the remnant lands in the aforementioned three parcels as the lots applied for and approved herein fully satisfy their share entitlement.

**2950 WHEREAS** a Partition Application (the “Original Application”) concerning Parcels 188, 189 & 190 Block 2738B West Central Registration Section dated 13 November 1998 was submitted in 1998 on behalf of the Estate of Henry O’Neal and was processed in part as Instrument 2226/1999;

**AND WHEREAS** further to Instrument 2226/1999, an Amended Application for Partition dated 18 September 2012 concerning the aforementioned three parcels in which Parcels 184 Block 2738B together with Parcels 340, 341 and 397-401 Block 2838B, West Central Registration Section were added and filed in 2012;

**AND WHEREAS:**

- 1) All the parcels in the two aforementioned partition applications mutated from Parcel 15 primarily save for a 0.337 acre of Parcel 15 which was exceptionally amalgamated (vide Mutation 101/1998) with Parcel 8 to form one of the subject parcels (i.e. Parcel 189);
- 2) Parcel 189 is specifically comprised of the 0.337 acre taken from Parcel 15 (Lot 26 in Survey Plan CA-2738B-075-T in Mutation 101/1998) and the entire 1.5 acres of Parcel 8
- 3) Parcel 8 and Parcel 15 measured 1.5 and 9.5 acres, respectively; and
- 4) Henry O’Neal held a ½ share in Parcel 8 and 21/219 shares in Parcel 15 (both in Block 2738B West Central Registration Section) equivalent to a 0.75 and 0.91 acre, respectively, for a total entitlement of 1.66 acres;

**NOW THEREFORE IT IS HEREBY DETERMINED AND ORDERED that:**

- (a) the Original Application and the Amended Application are essentially seeking to partition Henry O'Neal's share of Parcels 8 and 15 and are approved as follows:
- (i) the entitlement in Parcel 8 to be partitioned from Parcel 189 so that Lot 2 on Survey Plan CA-2738B-101-T measuring 1.037 acres (which includes the 0.75 acre entitlement in Parcel 8 plus only 0.287 acre of the 0.337 acre portion of Parcel 15 which was exceptionally amalgamated with Parcel 8) will be registered solely to "Malinda O'Neal as Personal Representative of the Estate of Henry O'Neal, deceased", subject to Leona M. Harney's approval of the proposed partition of the lands which were once Parcel 8, and payment of the relevant partition fees for Parcel 189;
  - (ii) The remaining entitlement in Parcel 15 to be taken in Parcel 188 measuring 0.503 acre which should be registered solely to "Malinda O'Neal as Personal Representative of the Estate of Henry O'Neal, deceased";
- (b) The partition applied for and approved in (i) will settle the entitlement of the Estate of Henry O'Neal in Parcel 8 and all such reference to that Estate should be removed from the remnant parcel (Lot 1 on Survey Plan CA-2738B-101-T measuring 0.940 acre) to be created when Parcel 189 is partitioned, and which Lot 1 is to be registered to "Leona M. Harney" as the sole proprietor, subject to her approval; and
