ORDER OF THE REGISTRAR OF LANDS

19006 This is an application (the "Application") filed with the Registry of Lands on 9th June, 2016 by Arthur Albert Fraser (the "Applicant") to be registered by prescription as proprietor to the Land. The Land is situated in Carrot Bay. The property is registered to James Callwood (the "Proprietor").

In accordance with section 137 of the Registered Land Act, Cap 229, the Registrar of Lands caused to be advertised Notice of the said application (the "Notice"). Advertisement was effected in two consecutive editions of the Island Sun newspaper, namely, the editions published for Saturday, 18th June, 2016 and 25th June, 2016.

The Registrar of Lands also caused the Notice to be advertised in the Virgin Islands Official Gazette in Vol L VII, Nos 35, 36 and 38.

The Notice required, *inter alia*, that:

"Anyone who has just caused to object to ARTHUR ALBERT FRASER being registered as proprietor by Prescription of the aforementioned Parcel 17 should do so in writing to the Chief Registrar of Lands no later than one (1) month from the 18th day of June, 2016."

The Registrar received no objections within the time limit prescribed in the Notice.

On 14th September, 2016 the Registrar convened a hearing with the Applicant and thereafter conducted a site visit. The Applicant was represented *pro se*.

Based on the evidence adduced by the Applicant, the Registrar is satisfied that the Applicant satisfies the criteria for prescriptive title to only that part of the Land upon which the Applicant's house is constructed.

IT IS THEREFORE HEREBY ORDERED that:

- (1) The Applicant, shall at his own expense, partition that portion of Parcel 17, Block 2336, Mount Sage Registration Section upon which the Applicant's Home is erected, and shall register the same in the name of the Applicant;
- (2) The remaining portion of Parcel 17, Block 2336, Mount Sage Registration Section shall continue to be registered in the name of the Proprietor; and
- (3) The sub-division shall preserve adequate access to the other structures on Parcel 17, Block 2336, Mount Sage Registration Section.

4. The qualifications for voters are set out in Section 68 of the Virgin Islands (Constitution) Order 2007, which is in the following terms:

Qualification of voters “68.

- (1) Subject to subsection (3),

a person shall be qualified to be registered as a voter for the purposes of elections if, and shall not be so qualified unless, he or she belongs to the Virgin Islands and on the qualifying date has attained the age of eighteen years and he or she either -

- (a) is domiciled and resident in the Virgin Islands on the qualifying date; or
- (b) on that date is domiciled in the Virgin Islands and resident in the United States Virgin Islands:

- (2) Subject to subsection (3), any person who was qualified to be registered as a voter immediately before the commencement of this Constitution shall continue to be so qualified thereafter.
- (3) No person shall be qualified to be registered as a voter under this Section who on the qualifying date –
 - a. is a person certified to be insane or otherwise adjudged to be of unsound mind under any law in force in the Virgin Islands;
 - b. is disqualified by or under any such law from being registered as a voter for the purposes of elections by reason of his or her having been convicted of an offence relating to elections; or
 - c. is under sentence of death imposed on him or her by a court or is serving a sentence of imprisonment (by whatever named called) for a term exceeding twelve months imposed on him or her by a court or substituted by competent authority for some other sentence imposed on him or her by a court.
- (4) In this Section “the qualifying date” means such date as may be appointed by or under any law in force in the Virgin Islands as the date with reference to which the qualifications or any person for registration are to be ascertained.
- (5) For the purposes of subsection (3)(c) –
 - a. two or more sentences of imprisonment that are required to be served consecutively shall be regarded as separate sentences if none of those sentences exceeds twelve month, but if any one of those sentences exceeds that term they shall be regarded as one sentence, and

- b. no account shall be taken of a sentence of imprisonment imposed as an alternative to or in default of the payment of a fine.
