14936 The Public is hereby informed that Voter Registration continues, and all persons who are eligible are encouraged to register to vote. To be qualified to register, a person must be a Belonger, 18 years of age or older.

Section 68 (1)

(a) is domiciled and resident in the Virgin Islands on the qualifying date; or (b) on that date is domiciled in the Virgin Islands and resident in the United States Virgin Islands.

Documents to be presented when registering are Birth Certificate, Virgin Islands Passport or a Belonger's Card. A Naturalization Certificate can also be used, provided the certificate is dated before June 15, 2007.

Please take note that in accordance with Section 17(1) of the Elections (Amendment) Act No. 14 of 2011; persons who have moved their place of residence and wish to transfer are encouraged to apply for a transfer.

Section 17(1)

"A registered voter who is ordinarily resident in the Territory and who moves his place of residence from within one local electoral district or polling division to another, may have his name transferred to the list of voters for the local electoral district or polling division to which he has moved, if he applies on Form No. 8 and establishes, to the satisfaction of the Supervisor of Elections, proof of residence within the local electoral district or polling division to which he has moved.

Supporting documentary evidence can be in the form of Cable, Water or Electricity bills, a rent receipt or a notarized document, stating new address.
