Labour Code (Work Permit Exemption) (No. 16) Order, 2006

[Gazetted 12th October, 2006]

The Minister, in exercise of the powers conferred by section F3 of the Labour Code Ordinance (Cap. 293), makes the following Order:

Citation.

1. This Order may be cited as the Labour Code (Work Permit Exemption) (No. 16) Order, 2006.

Exemption.

2. Division F of the Labour Code Ordinance shall not apply to the persons specified in the Schedule, but the exemptions shall be subject to the conditions set out therein.
